General Information

Range: Victoria Fish and Game Club, Victoria BC.

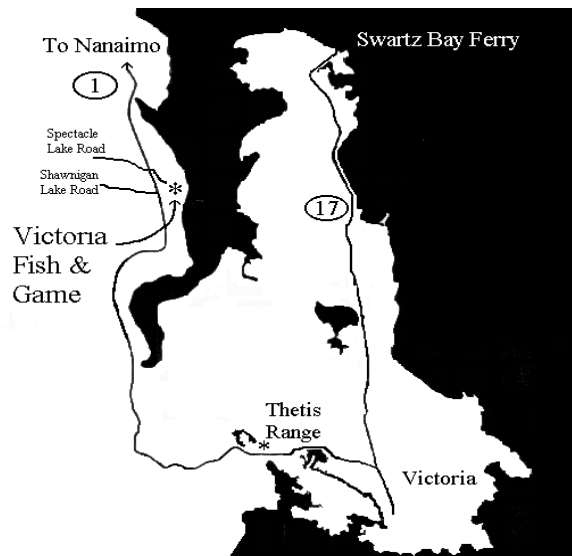
The Victoria Fish and Game Club is located at 700 Holker Place. From Victoria, follow the Trans-Canada Highway (Highway 1), north toward Nanaimo. Holker Place is the first road on the right hand side of the highway after you pass the turn off for the south end of Shawnigan Lake. If coming from the north, Holker Place is no longer accessible from southbound lanes. Drive past Holker Place and turn right on South Shawnigan Lake Road. Safely turn around and return to the highway to drive northbound to the turnoff. There are road signs in place indicating the turn to the Victoria Fish and Game Club. Exact location for those with a GPS: 330m elevation; N48°33.960'; W123°33.708'. The telephone number for the caretaker on duty is (250) 858-8342.

Meals:

Coffee, beverages, breakfast, and lunch will be available on both days of competition. Breakfast will be available at 8:00AM both days.

Alcoholic Beverages:

Absolutely no alcoholic beverages will be allowed on the range or anywhere on the grounds during the matches.



Eligibility:

All CPCA members are invited to compete in this event with a maximum of 45 competitors.

Rules:

Current CPCA rules shall govern.

CPCA Membership:

All competitors must hold a valid 2016 CPCA membership to compete in the match. Memberships will be available for purchase at the Registration Desk.

Competition:

CPCA Open PPC 1500 Match, CPCA Duty Pistol 1500 Match, Fixed Sight Match, Snub Nose Match, Distinguished Semi-Auto Match, Distinguished Revolver Match, and Team Match.

Sighting In:

Shooting will be permitted between 12:00PM and 3:00PM on Friday, October 7th only.

Challenges and Protests:

Challenges will be governed by CPCA Rule 16.1; protests will be governed by CPCA Rules 16.2 to 16.4. The challenge fee is \$3.00 and the decision of the Chief Referee is final. **Scoring Plugs:** No competitor will use a scoring plug on the target at any time but may use scoring overlays in accordance with Rule 14.3.1. The Chief Referee may use a scoring plug to check values and determine the outcome of the challenges.

Team Matches:

Team Classifications will be determined as per CPCA Rule 19.12 using CPCA percentages towards determining a team average for classification purposes. All CPCA classifications will be used. Teams and team members must be declared before any team member fires in the Team event as per CPCA Rule 12.3. Team score may be taken from Match 5 of the Individual event **if** competitors and their entire team have completed the declaration form prior to shooting the PPC 1500 Match. **The declaration form must indicate who is using their Match 5 score.**

Scoring:

Targets will be scored at the completion of each relay. Competitors must do all scoring. Both the scorer and the competitor must sign the scorecard before it is handed in. Each competitor should be certain his/her scorecard is filled out correctly.

Target Handling:

All competitors will be responsible for picking up new targets and mounting them on the target frames upon command. In addition, each competitor is required to fill in the legend and is required to ensure that his/her name is on the target. **The competitor assigned to score it will carry the fired target from the firing line to the proper scoring area.** B-27 targets will be in use.

Coaching:

Coaching is permitted in Team Matches only. Coaching will not be permitted for competitors using their 1500 Match 5 score as their team score. Coaches will not interfere in any way with other competitors. CPCA Rules 12.1 to 12.6 inclusive will apply.

Refiring:

No refires will be permitted for any malfunction of ammunition or equipment. Firearms must be unloaded and holstered at all times except when on the firing line.

Merchandise Awards:

There will be merchandise awards for all competitors entered in the 1500 PPC match. Merchandise prizes will also be awarded in the Duty Pistol match for Grand Aggregate and first in each class. Cash prizes may be available where there are not enough merchandise prizes to satisfy the number of competitors.

CPCA Awards:

If supplied, we will be presenting the CPCA acrylic awards for Grand Aggregate and first in each class for the 1500 PPC and Duty Pistol.

Classifications

CPCA Classifications will be used: GRAND MASTER, DISTINGUISHED MASTER, MASTER, EXPERT, SHARPSHOOTER, and MARKSMAN.

Rule 19.1 will be enforced placing unclassified shooters in the Grand Master Class.

Failure to produce a classification card may result in a competitor being placed in Grand Master classification.

Match Definitions

MATCH #1 through #15 to be shot as per CPCA Police Pistol and Revolver Combat Rules 2007.

MATCH #6 is the same course of fire as MATCH #5. All firearms are permissible as long as they have non-adjustable sights and meet the physical requirements under CPCA rules of general firearms.

MATCH #16: Guest and VIP Match - All shooters must be accompanied and coached on the firing line by a CPCA member. Equipment and ammunition can be supplied. Course of fire: 6 rounds, 7 yards, 15 seconds; 6 rounds, 15 yards, 25 seconds; 12 rounds, 25 yards, 60 seconds. CPCA competitors are not permitted to shoot the VIP or Guest Match.
